This raises the total number of COVID-19 cases to 4,175 in Cameron County. There have also been an additional forty-two (42) individuals who have recovered, raising the total number of recovered individuals to 2,590.

Cameron County Public Health continues to work with the seven nursing home facilities and one detention center in addressing the COVID-19 outbreaks. To date, the Cameron County cases arising from the Port Isabel Service Processing Center has 11 employees and 77 detainees who have tested positive.
