CAMERON COUNTY TO OPEN TWO COVID-19 VACCINATION DRIVE-THRU CLINICS

Cameron County will host two COVID-19 vaccination drive-thru clinics this week at the Los Fresnos Fire Department located at 100 Rodeo Dr. in Los Fresnos. The Moderna vaccine will only be administered to individuals 65 years of age or older on Thursday, January 21, 2021, and to individuals within the Phase 1A and 1B priority groups on Friday, January 22, 2021.

For the vaccination clinic to be held on Thursday, January 21, 2021, only for individuals 65 years of age and older, limited number of vouchers will be available for pick-up starting tomorrow, Wednesday, January 20, 2020, at 8:00 a.m. at the four Cameron County Commissioner Precinct Warehouses below:

For Friday's vaccination clinic, as a reminder, Phase 1B guidelines include persons who are 65 years of age or older, and persons 18 years of age or older with at least one chronic medical health condition below:

- Cancer,
- Chronic Kidney Disease,
- COPD (Chronic Obstructive Pulmonary Disease),
- Heart Conditions, such as heart failure, coronary artery disease or cardiomyopathies,
- Solid Organ Transplant,
- Obesity and severe obesity (body mass index of 30 kg/m² or higher),
- Pregnancy,
- Sickle cell disease or
- Type 2 diabetes mellitus.

Cameron County to Open Two COVID-19 Vaccination Drive-Thru Clinics

Cameron County Public Health has partnered with school districts in Cameron County to administer the vaccines. The vaccination clinic to be held on Thursday, January 21, 2021 will be available starting at 6:00 a.m. and must be in line no later than 12:00 p.m. Friday's vaccination clinic will be on a first come, first served basis starting at 6:00 a.m. until supplies last. The public is asked to please remain in your vehicle upon arrival and complete the consent and registration form ahead of time. These forms can be found at www.cameroncounty.us/publichealth/index.php/coronavirus/. Forms will also be provided onsite. No drop-offs or walk-ins will be allowed.

It is expected that Cameron County Public Health will receive additional COVID-19 vaccines in future weeks and will provide additional vaccination clinic updates as allocations are confirmed. Cameron County is dedicated to administering COVID-19 vaccines in accordance with the guidance from the State of Texas and will provide updates as vaccination are made available.
