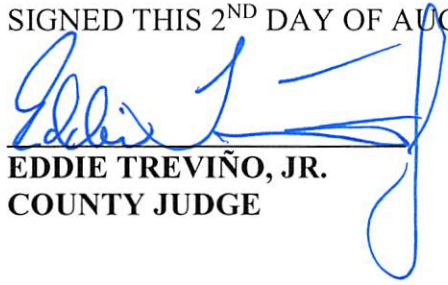
**PUBLIC NOTICE OF REGULAR MEETING

AND WILL CONSIDER APPROVAL OF A TAX ABATEMENT AGREEMENT**

1. THE NAMES OF THE PROPERTY OWNER AND THE NAME OF THE APPLICANT FOR THE TAX ABATEMENT AGREEMENT ARE: ANNOVA LNG COMMON INFRASTRUCTURE, LLC AND ANNOVA LNG BROWNSVILLE A, LLC.
2. THE NAME AND LOCATION OF THE REINVESTMENT ZONE IN WHICH THE PROPERTY SUBJECT TO THE AGREEMENT IS LOCATED: CAMERON COUNTY IS AN ENTERPRISE ZONE AND THE PROJECT SITE IS A 730.92 ACRE TRACT IN THE BROWNSVILLE NAVIGATION DISTRICT AT THE PORT OF BROWNSVILLE.
3. A GENERAL DESCRIPTION OF THE NATURE OF THE IMPROVEMENTS OR REPAIRS INCLUDED IN THE AGREEMENT IS: A NEW LIQUEFIED NATURAL GAS (LNG) EXPORT TERMINAL ON THE PORT OF BROWNSVILLE INCLUDING UP TO SIX LNG TRAINS AND SURROUNDING INFRASTRUCTURE.

4. THE ESTIMATED COST OF THE IMPROVEMENTS OR REPAIRS IS ESTIMATED TO BE \$3.5 BILLION WITH ESTIMATED PROPERTY TAX VALUES OF \$1.8 BILLION.
