

INTERLOCAL COOPERATION AGREEMENT

THIS AGREEMENT is entered into and between the COUNTY OF CAMERON, TEXAS, hereinafter referred to as "COUNTY" and the HARLINGEN CONSOLIDATED INDEPENDENT SCHOOL DISTRICT, hereinafter referred to as "DISTRICT", pursuant to V.T.C.A., Government Code, Chapter 791, cited as the Interlocal Cooperation Act.

1. LOCATION OF PROJECT: Cameron County, Harlingen, Texas.
2. PROJECT TO BE COMPLETED: HCISD cadets and other students will assist Cameron County Pct. 4 with filling sandbags.
3. COUNTY will provide all materials (sand, sandbags, shovels) and will drop off the materials at a secure sight provided by HCISD.

COUNTY will be responsible for providing the materials to HCISD for purposes of filling sandbags. The DISTRICT will be responsible for providing the labor for the completion of the sandbags.
4. COUNTY and DISTRICT neither makes nor gives any warranties, express or implied, as to the quality or durability of the work upon completion.
5. This Interlocal Agreement will continue for a period of three (3) years. This Interlocal Agreement may be terminated by either party without cause by giving thirty (30) days written notice to the other party of its intent to terminate the Interlocal Agreement.
6. The rules, regulations and orders of COUNTY shall govern this agreement and the parties agree the COUNTY shall supervise the performance of this agreement.
7. The agreement shall have no legal force or effect until such time as it is properly adopted and approved by the CAMERON COUNTY COMMISSIONERS COURT AND THE HARLINGEN CONSOLIDATED INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES. This agreement shall terminate at the completion of the project.
