THIS IS THE ONLY APPROVED INSTRUCTION FOR USE ON YOUR RFQ. ITEMS BELOW APPLY TO AND BECOME A PART OF TERMS AND CONDITIONS OF RFQ. ANY EXCEPTIONS THERETO MUST BE IN WRITING.

1. **ORIGINAL AND SEVEN (7) COPIES OF RFP’s MUST BE SUBMITTED** Each RFQ shall be placed in a separate envelope completely and properly identified with the name and number of the RFQ. RFQ’s must be in the Purchasing Department **BEFORE** the hour and date specified.

2. RFQ's MUST give full firm name and address of the Proposer. Failure to manually sign RFQ will disqualify it. Person signing RFQ should show TITLE or AUTHORITY TO BIND THE FIRM IN A CONTRACT.
3. RFQ's CANNOT be altered or amended after deadline time. Any alterations made before deadline time must be initiated by Proposer or his authorized agent. No RFQ can be withdrawn after opening time without approval by the Commissioners Court based on a written acceptable reason.
4. The County is exempt from State Sales Tax and Federal Excise Tax. DO NOT INCLUDE TAX IN RFQ. Cameron County claims exemption from all sales and/or use taxes under Texas Tax Code §151.309, as amended. 5. Any Catalog, brand name or manufacturer's reference used in a RFQ invitation is descriptive-NOT restrictive-it is to indicate type and quality desired. RFQ's on brand of like nature and quality will be considered. If RFQ is based on other than reference specifications, proposal must show manufacturer, brand or trade name, lot number, etc., of article offered. If other than brand(s) specified is offered, illustrations and complete descriptions should be made part of the RFQ. If Proposer takes no exception to specifications or reference data, he will be required to furnish brand names, numbers, etc. as specified.

Prices should be itemized. County also reserves the right to award either with or without trade-in, if applicable.
10. RFP unit price on quantity specified – extend and show total. In case of errors in extension, UNIT prices shall govern. RFP's subject to unlimited price increase will not be considered.
11. This is a RFQ inquiry only and implies no obligation on the part of Cameron County.
12. Acceptance of and final payment for the item will be contingent upon satisfactory performance of the product received by Cameron County.

14. It is expected that the Proposer will meet all state and federal safety standards and laws in effect on the date of the RFQ for the item(s) being specified, and the particular use for which they are meant.

PHYSICALS / WELLNESS CHECKUP (ON SITE) - EMPLOYEES

I. GENERAL

Cameron County Commissioners Court is requesting Qualification Statements from firms that can adequately demonstrate resources, experience and qualifications necessary to provide laboratory services; ensure that laboratory service meet county and federal, state standards; ensure quality, yet be cost effective, laboratory service delivery system; maintain adequate records on laboratory services ordered as well as patient profiles; audit laboratory services' delivery system; with lab testing facilities brought to designated Cameron County locations upon arrangement

GOAL: In order to ensure that the Employees of the Cameron County have quality, laboratory services will be available to perform diagnostic tests upon request; diagnostic tests will be performed in an expedient manner.

The term of contract will be: **3 years.** (from Contract award date)

EVALUATION AND SELECTION CRITERIA

WEIGHTED QUANTITATIVE SCORING:

Each Vendor will be assigned a score of 1- 4 by each evaluator for each criteria

- 4 = Very good / Exceeds expectations
- 3 = Above expectations
- 2 = Meets expectations
- 1 = Does not meet expectations
- 0 = non responsive

Utilization of 0 by evaluator requires Evaluation Committee's full consensus.

Evaluators score by category will be multiplied by the assigned weight for each criteria by vendor then totaled. Scoring for price will be a ratio and based on a pro rata factor of the best price submitted.

Ex: Vendor W - price \$100,000 = 4 points X assigned weight (ie: 25%) = 100 points

Vendor X – price \$150,000 = 2.66 points X assigned weight (ie: 25%) = 66.6 points

Vendor Y – price \$200,000 = 2 points X assigned weight (ie: 25%) = 50 points

$\$100,000 \div \$200,000 = .50 \times 4 = 2 \times 25 = 50$

$\$100,000 \div \$150,000 = .66 \times 4 = 2.666 \times 25 = 66$

Once RFPs are reviewed and scored, a short list will be compiled. Interviews may be conducted with Proposers determined by total score rankings. Additional information may be required at that time. Negotiations will begin with the Proposer selected for the project. Commissioners Court will make the final selection and possible approval of the contract.

The Request for Qualifications will be evaluated using the following Weighted Quantative Criteria:

- A. Responsiveness to the Request for Qualifications (15)
 - 1. Requested information included and thoroughness of response to the forms included in attachments (if any).
 - 2. Understanding of the project
 - 3. Creativity of proposed approach to solving the problem
 - 4. Clarity and brevity of the response

- B. Staffing Plan (15)
 - 1. Provision for the required disciplines and skills
 - 2. Provision for participation by Firm's key personnel
 - 3. Qualifications for key personnel adequate for requirement
 - 4. Qualifications of proposed consulting team

- C. Firm's capability to provide the services (50)
 - 1. Background of the firm
 - 2. Relevant experience of the Firm
 - 3. Specific experience on active government services
 - 4. Methodology proposed to meet objective's services
 - 5. Location in the general geographical area of the services and knowledge of the locality of the services
 - 6. References

- D. Track record of services completed on time and within budget (20)

Once Qualification Statements are reviewed, a short list may be compiled. Interviews may be conducted with the firms determined to be most qualified. Additional information may be required at that time. Negotiations will begin with the firm determined to be most qualified for the project. Commissioners Court will make the final selection and approve the proposed contract.

Negotiations will include selection of specific services as in the best interest of Cameron County. The selected firm must be prepared to enter negotiations with each service/project individually represented by costs and necessity to the overall analysis. Cameron County may elect to contract for any, or all, of the proposed services after negotiations.

II. SCOPE OF SERVICES

The intent of this solicitation is to obtain physicals / Wellness check-up (on site) services of a provider with demonstrated relevant experience:

CONSIDERATIONS:

- . Service provider must have an established mechanism (i.e. courier service) by which to retrieve specimens.
- . Service provider must be state certified and meet all state and federal laws.
- . Service provider must maintain a level of liability insurance that is comparable with other diagnostic facilities in South Texas.
- . Service provider must submit copies of medical certification of all staff including:

Medical Review Officer Certification

Proof of Physician's **current and active License by the State of Texas**

- . Vendor will provide all materials needed for blood collection.
- . Identify reports with patient name, date of birth and identification number.

- . all HIPPA requirements will be fully complied with at all times.

COUNTY TO RESPONSIBILITIES:

- . County will coordinate, arrange, schedule (time, date, location) for employees requiring Physicals / Wellness checkups with vendor and employees.

III. QUALIFICATIONS' STATEMENTS

Response to this RFQ should be limited to the following maximum page limitations and specified format in order to simplify evaluation. Pages should be 8 ½ x 11 inches in a point type that is legible and easily read. All sections should be properly identified.

Respond to the following:

- A. Executive summary to include name, address, and telephone number of the firm submitting the RFP, a summary of the firm's interest in this project, and the name of one or more individuals authorized to represent the consultant in its dealings on a contractual basis. The Executive Summary should also include a statement that indicates if current workload allows for project to be completed on an accelerated schedule (maximum 2 pages).
- B. Names and qualifications of principals and individuals employed by the firm that will participate in these services and their individual responsibilities (maximum 10 pages).
- C. Verifiable experience on similar size and complexity of projects concentrating on the type of services specified herein. Experience should be specific by indicating level of involvement of services completed by you responding to this RFQ and description of services contributed (maximum 2 pages).
- D. Verifiable experience with services for other entities and examples of services to include Name/Location, Owner Representative, Phone Number, and level of involvement by you (maximum 2 pages).
- E. Reference to include contact person, address and phone number (2 pages).
- F. A narrative outline describing the methodology to be taken by the consultant firm discussing any concerns which must be addressed in a project of this nature. The methodology should be specific in firm's ability to stay within budget, and what methods of cost containment are utilized (maximum 2 pages).

Methodology should be specific in approach to:

- 1. cost containment
- 2. review of plans and providing Cameron County with continuous, update on costs;
- 3. measuring performance against quality, time and cost during design, and implementation phase of the services;
- 4. assist in preparation of contract/documents;
- 5. recommend changes that will result in cost effective solutions;
- 6. assist in proposing phase;
- 7. coordination of services phase;
- 8. understanding of Guaranteed Maximum Price services to comply with the State of Texas Local Government Code Proposal Requirements and how liabilities, bonds, and insurance are relevant to the scenario in relation to Owner, laboratory diagnostic;
- 9. What opportunities of economics of scale will be beneficial to Cameron County through coordination of separate projects and the parameters or restrictions involved in taking advantage of this benefit?

- G. A disclosure statement which shall disclose all, potential conflicts of interest related to this project. The disclosure statement must be addressed specifically in your response, even if no conflict exists (maximum 1 page).
- H. You shall disclose any outstanding claims against you (pages as needed).
- I. You shall include a list of all, current insurance applicable to these services including coverage amounts and on Insurance Company's Proof of Coverage Document (pages as needed).
- J. You shall include a sample contract (absent of proposed fees) to demonstrate the contractual relationship between the owner and laboratory diagnostic service provider (pages as needed).
- K. Disclose hours of service.

COUNTY PHYSICALS / TESTING QUESTIONS

- 1. Can you perform lab accurate, diagnostic blood work via fingerstick using a portable lab?**

- 2. Can a screening results file be provided to BCBS of TX? Are you willing to provide the file in BCBS's format? Is there a charge for this feed?**

- 3. Do you use clinicians to review the screening results with the employees at the time of the screenings?**

- 4. Are you able to provide all the metrics the County is requesting (waist circumference, fasting glucose, etc)? Are there any additional measurements you get (BMI, etc)?**

- 5. What materials are provided to employees? Are the materials/results provided at the screening, provided via website, or mailed to their homes afterwards? If mailed, how soon after the screenings are they put in the mail? Is there an additional charge to mail results to employee homes?**

- 6. Do you provide your own tables, chairs, privacy structures, etc and do the set-up and take-down? Are there additional charges/ fees for any of this? Do you provide privacy areas? Please describe the layout you prefer.**

7. Do you provide any materials the County can use to promote the screenings (ex. Flyer, posters, etc)? Do you provide them in electronic or print format? Is there an extra charge for these materials?

8. Do you provide an aggregate report or any information to the County on the screening results?

9. Are you willing to provide identifiable results to a third party if requested (results with employee SSN or date of birth)? If so, will you allow your release form that is signed by the employee be edited to include third party?

10. Do you provide fasting and non-fasting tests?

11. Can you provide lab accurate bloodwork and consultations with clinicians in one appointment?

12. What resources do you need from the County? (ex. Tables, chairs, number of rooms, etc)

13. What happens if an employee cannot make the onsite screenings? Is there an alternative you can provide?

14. Will the alternative screenings you propose include the same components as the onsite screenings? If your alternative is lab only, how do you propose getting height, weight and waist circumference?

15. Do you have a toll free call center to handle individual calls from employees regarding instructions and questions?

16. Do you provide an online scheduler? Can employees call in to schedule an appt?

17. How do you handle walk-ups (employees without an appointment)?

18. What is your cost per employee for the screenings alone? (On-site)

19. What is your cost per employee for the screenings alone? (alternative screening)

20. What is your minimum participation requirement for each location (minimum number of County Employees required for on site visit event to occur at a location) ?

21. What is your minimum fee requirement per location?

22. Are travel costs included in the fees above? If not, how are those charges billed? Please provide an estimated travel charge (if applicable) knowing all 5 screening days are in the Cameron County.

NOW THEREFORE, BE IT ORDERED by the Commissioners Court of Cameron County, that the following rules be adopted regarding Cameron County and persons interested in doing business with Cameron County:

- 1. Cameron County may refuse to enter into a contract or other transaction with a person with a past due debt to Cameron County, including delinquent ad valorem taxes, even if the person is the lowest bidder or successful proposer; and
2. For purposes of this Order, a debt is past due if it is not received in the County Treasurer's Office by the due date in a written agreement or notice, and ad valorem taxes are past due if not received in the County Tax Assessor/Collector's Office by February 1st following the January 1st on which the ad valorem taxes are due.
3. For purposes of this Order, a person includes an individual, sole proprietorship, corporation, nonprofit corporation, partnership, joint venture, limited liability company, and any other entity that proposes or otherwise seeks to enter into a contract or other transaction with Cameron County requiring approval by the Commissioners Court.

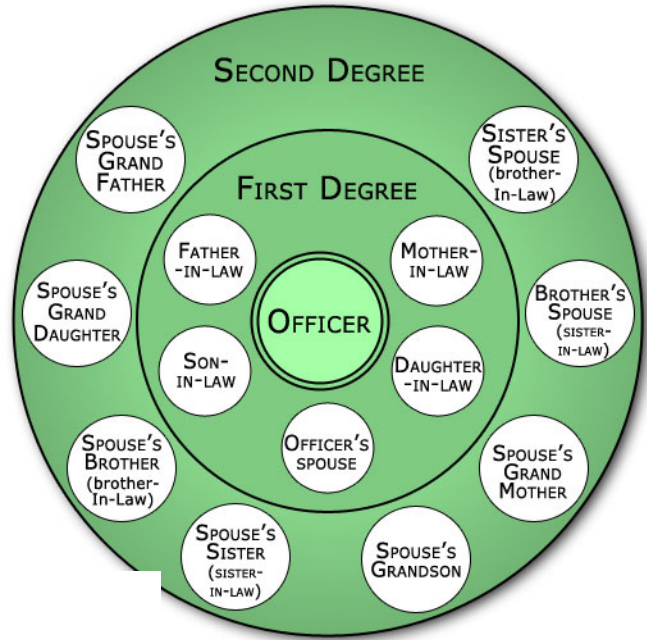

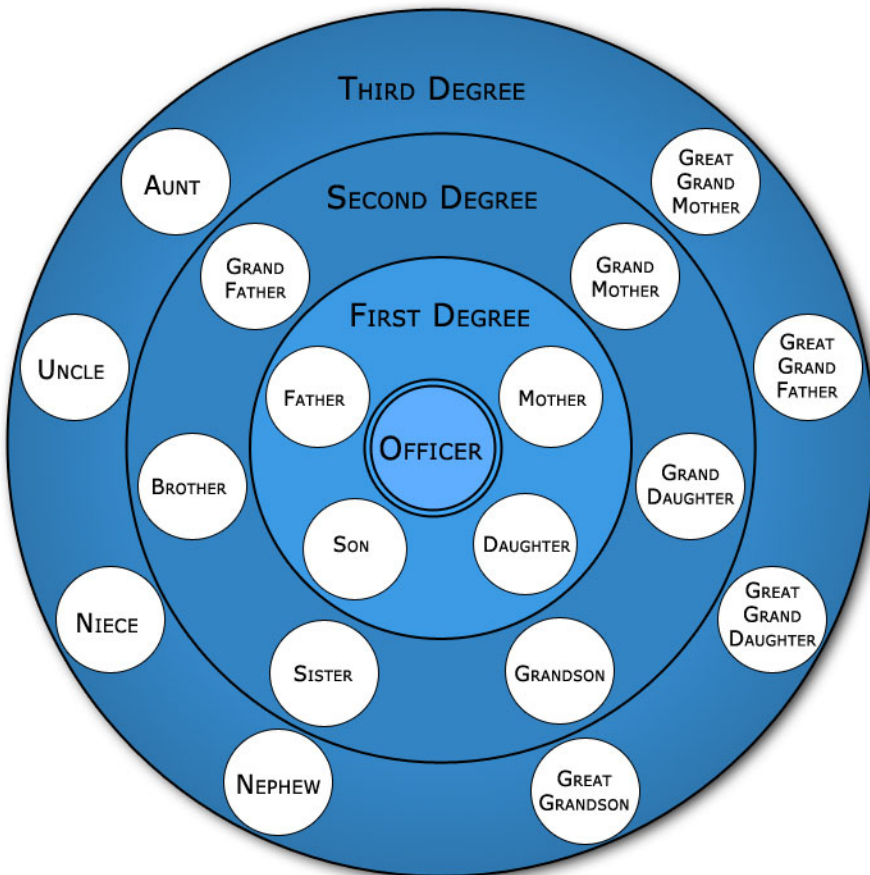

Format and Content - Protesting Respondents shall include, in their written protest to the Cameron County Purchasing Department, all facts and arguments upon which they rely. Respondents shall, at a minimum, provide:

1. Information about the protesting vendor; name of firm, mailing address, phone number and name of individual responsible for submission of the protest.
2. Information about the acquisition and the acquisition method.
3. Specific and complete statement of the County's action(s) protested.
4. Specific reference to the grounds for the protest.
5. Description of the relief or corrective action requested.
6. For protests to the Protest Committee, a copy of the Purchasing Department's written decision on the protest.

Review Process:

1. Upon receipt of a Respondent protest, the Purchasing Department shall postpone further steps in the acquisition process until the Respondent protest has been resolved.
2. The Department's internal protest review procedures consist of the following: a) The Purchasing Department shall perform an objective review of the protest by individuals not involved in the acquisition protested. The review shall be based on the written protest material submitted by the Respondent. b) A written decision will be delivered to the Respondent within five business days after receipt of the protest, unless more time is needed. The protesting Respondent shall be notified if additional time is necessary.

Final Determination - The final determination shall:

1. Find the protest lacking in merit and uphold the agency's action; or
2. Find only technical or harmless errors in the agency's acquisition process conduct, determine the agency to be in substantial compliance, and reject the protest; or

Failure of the Respondent to maintain adequate coverage shall not relieve the Respondent of any contractual responsibility or obligation.

SCANNED RE-TYPED RESPONSE - FLOPPY DISK: If in its RFQ response, Respondent either electronically scans, re-types, or in some way reproduces the County's published RFQ package, then, in event of any conflict between the terms and provisions of the County's published RFQ specifications or any portion thereof, and the terms and provisions of the RFQ response made by Respondent, the County's RFQ specifications as published shall control. Furthermore, if an alteration of any kind to the County's published RFQ specifications is only discovered after the contract is executed and is or is not being performed, the contract is subject to immediate cancellation.

SILENCE OF SPECIFICATIONS: The apparent silence of specifications as to any detail, or the apparent omission from it of a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices are to be used.

SUPPLEMENTAL MATERIALS: Respondents are responsible for including all pertinent data in the returned RFQ package. Literature, brochures, data sheets, specification information, completed forms requested as part of the RFQ package and any other facts which may affect the evaluation and subsequent contract award should be included. Materials such as legal documents and contractual agreements, which the respondent wishes to include as a condition of the RFQ, must also be in the returned RFQ package. Failure to include all necessary and proper supplemental materials may be cause to reject the entire RFQ.

USAGE REPORTS: Cameron County reserves the right to request, and receive at no additional cost up to two (2) times during the contract period, a usage report detailing services furnished to date under a contract resulting from this RFQ. The reports must be furnished no later than five (5) working days after written request and itemize all purchases to date by the Cameron County department using the services with a description of services rendered, the unit and total price.

WARRANTY: Respondents may not limit or exclude any implied warranties. **Respondent warrants that services provided to the County shall conform to the highest commercial and/or professional standards in the industry.**

APPLICABLE LAW

ASSIGNMENT DELEGATION: No right or interest in this contract shall be assigned or delegation of any obligation made by Respondent without the written permission of the County. Any attempted assignment or delegation by Respondent shall be wholly void and totally ineffective for all purposes unless made in conformity with this paragraph. Any contract entered into pursuant to this request is not assignable, nor the duties thereunder, by either party, without the written consent of the other party, the Commissioners Court, and County Auditor.

CONTRACT OBLIGATION: Cameron County Commissioners Court must award any resulting contract and the County Judge or other person authorized by the Cameron County Commissioners Court must sign the contract before it becomes binding on Cameron County or the Respondent. Department heads are NOT authorized to sign agreements for Cameron

County. Binding agreements shall remain in effect until the contract requirements have been satisfied.

ERRORS AND OMISSIONS: Errors and Omissions in the RFQ of any provision herein described will not be construed as to relieve the Respondent of any responsibility or obligation requisite to the complete and satisfactory implementation, operation, and support of all obligations under any resulting contract.

FORCE MAJEURE: If, by reason of Force Majeure, either party hereto shall be rendered unable wholly, or in part, to carry out its obligations under this RFQ and any resulting contract, then such party shall give notice and full particulars of Force Majeure in writing to the other party within a reasonable time after occurrence of the event or cause relied upon, and the obligation of the party giving such notice, so far as it is affected by such Force Majeure, shall be suspended during the continuance of the inability then claimed, except as hereinafter provided, but for no longer period, and such party shall endeavor to remove or overcome such inability with all reasonable dispatch. The term "Force Majeure" as employed herein, shall mean acts of God, strikes, lockouts, or other industrial disturbances, act of public enemy, orders of any kind of government of the United States or the State of Texas or any civil or military authority, insurrections, riots, epidemics, landslides, lightening, earthquakes, fires, hurricanes, storms, floods, washouts, droughts, arrests, restraint of government and people, civil disturbances, explosions, breakage or accidents to machinery, pipelines or canals, or other causes not reasonably within the control of the party claiming such inability. It is understood and agreed that the settlement of strikes and lockouts shall be entirely with the discretion of the party having the difficulty, and that the above requirement that any Force Majeure shall be remedied with all reasonable dispatch shall not require the settlement of strikes and lockouts by acceding to the demands of the opposing party or parties when such settlement is unfavorable in the judgment of the party having the difficulty.

HOLD HARMLESS AGREEMENT: The successful Respondent, shall indemnify and hold Cameron County harmless from all claims for personal injury, death and/or property damage resulting directly or indirectly from Respondent's performance. Respondent shall procure and maintain, with respect to the subject matter of this RFQ, appropriate insurance coverage including, as a minimum, public liability and property damage with adequate limits to cover Respondent's liability as may arise directly or indirectly from work performed under terms of this RFQ. Certification of such coverage must be provided to the County upon request.

INTERPRETATION PAROLE EVIDENCE: Unless a separate contract or addendum hereof is prepared and entered into following the award of this RFQ to a successful respondent, this writing is intended by the parties as a final expression of the terms of this RFQ and the general terms of any resulting contract with the selected Respondent. No course of prior dealings between the parties and no usage of the trade shall be relevant to supplement or explain any term. Acceptance or acquiescence in a course of performance rendered under this RFQ and any resulting contract shall not be relevant to determine meaning even though the accepting or acquiescing party has knowledge of the performance and opportunity for objection.

LATE RESPONSES: RFQ responses must be received by the County before the hour and date specified. Responses received after the time and date specified will be disqualified and may be returned to sender. The County is not responsible for lateness or non-delivery of mail, delivered to wrong office, carrier, etc.

REMEDIES: The successful Respondent and County agree that both parties have all rights, duties, defenses and remedies available under law.

RIGHT TO ASSURANCE: During the RFQ process and any resulting contract, whenever a respondent or the County in good faith has reason to question the other's intent to perform, demand may be made that the other party give written assurance of intent. In the event that a demand is made, and no assurance is given within five (5) days, such failure may be treated as an anticipatory repudiation of the RFQ and any resulting contract.

SEVERABILITY: If any section, subsection, paragraph, sentence, clause, phrase or word of these requirements or the specifications shall be held invalid, such holding shall not affect the remaining portions of these requirements and the specifications and it is hereby declared that such remaining portions would have been included in these requirements and the specifications as though the invalid portion had been omitted.

VENUE: Both parties agree that venue for any litigation arising from this contract shall lie in Cameron County, Texas. These General Terms and Conditions shall be incorporated in the response to the RFQ and any resulting contract. The Respondent shall specifically state acceptance of these terms and conditions as a basis for providing the County with a response. The Respondent shall state any exceptions desired to these terms and conditions and may suggest alternate wording that addresses the intent of the term or condition. The County may accept or reject any suggestions in accordance with law.
