

Instructions for Completing the Application:

- 1) Complete all of the requested applicant information. (Do not sign the application until you are in the presence of a notary public.)
- 2) Have the application notarized.
- 3) Obtain the following proper form of identification and proof of age:
A copy of your birth certificate. If you were born in the State of Texas, a copy may be purchased for a fee from the CAMERON COUNTY Clerk's Administrative Office, or through the City (City Hall) in which you were born.
- 4) Upon completing the tasks outlined above, mail or deliver in person, both of the items to the following address:

Information on the Withdrawal of Registry Funds

- 1) Your application will not be processed unless you have turned 18 or have otherwise reached your majority (legal age).
- 2) Once the application is received, a Court Order to Withdraw Funds from the Registry of the Court will be prepared.
- 3) The Order must be signed by the Judge before a check can be issued.
- 4) You will be called when your check is ready to be picked up at the following address:

- 5) If you reside outside of CAMERON COUNTY the check can be mailed to you, but you must submit a copy of your valid driver's license and an authorized picture identification card along with your application.
- 6) Your check will be ready approximately two weeks from the time the Judge signs the order directing the County Clerk to disburse the funds.
